\*\* Fee for membership renewal – Fee has to be paid in case member didn't pay membership fee or non-flying membership fee for the last year together with regular membership fee for actual year.

\*\*\* Pilot licence and airworthiness review certificate for any proficiency they are out of date - it means from 1. day when your pilot licence has expired (e.g.: your pilot licence expired 23.09.2022 but your confirmation from doctor has date 25.09.2022).
